Measures to improve the energy efficiency in water supply:

mainly pumping systems in well fields and pumping stations in water supply (including in particular M&E equipment, measuring devices, SCADA and the corresponding physical network infrastructure)

Requested Consultant Services:

The consultant's activities shall mainly comprise the following:

- Collection of existing data and intensive field investigations incle appropriate measurements for assessing the status-quo situation;
- Elaboration of feasible concepts for improving the energy efficiency of installations and related infrastructure; Summarising the basic findings, elaborated and agreed upon concepts, proposed implementation measures and recommendations in project reports.

The Water Authority of Jordan (WAJ) hereby invites Jordanian and international qualified consulting firms, experienced in the water sector and in the region, to submit their pre-qualification documents for the consulting services supporting and facilitating the effective preparation of energy efficiency concepts for the Jordanian Water Sector.

The consultancy services shall be provided by a consultancy consortium between international and local firms or experts.

Also Jordanian companies can be seen as international firms, in case that they have project experience outside of Jordan (in minimum three consulting projects in the water sector with an amount of each project > 200 000 JD).

Certified statement of financial capacity of the Lead Consultant and all associated partners have to show a minimum annual turnover of the Lead Consultant of more than EUR 1 (one) million within the last 3 years (balance sheets and profit and loss accounts of the last three years).

The prequalification of experienced consultants will follow the latest version of the "Guidelines for Assignment of Consultants in Financial Cooperation Projects" (refer to website: www.kfw-entwicklungsbank.de).
