OSCE Ministerial Council

Bosnia and Herzegovina at the 31st OSCE Ministerial Council

Minister Konaković welcomed the OSCE's focus on economic and environmental security and efforts to promote sustainable development in the region because it is evident that economic differences, scarcity of resources and environmental degradation threaten collective security, encourage tensions and displacement and directly affect communities that need to be protected.

The Minister emphasized that the coming year will undoubtedly bring challenges, from geopolitical tensions to frozen conflicts and new security threats, but that the collective ability to respond effectively will shape the OSCE's role in maintaining stability and security across the region and beyond.

Meeting with the Minister of Foreign Affairs of the State of Kuwait

On December 17-18, 2024, Minister of Foreign Affairs of Bosnia and Herzegovina, Mr. Elmedin Konaković, conducted an official visit to the State of Kuwait, reinforcing the strong ties between the two nations.

During the meeting with Kuwait's Minister of Foreign Affairs, H.E. Abdullah Ali Al-Yahya, Minister Konaković discussed Bosnia and Herzegovina's progress toward EU membership and the current political and security situation. The ministers also exchanged views on global challenges, including the conflict in Ukraine, developments in the Middle East, and opportunities for enhanced cooperation in tourism, a sector identified as a promising area of mutual interest.

Meeting with the Prime Minister and Minister of Foreign Affairs of the State of Qatar

The meeting highlighted the strong and friendly bilateral relations between the two countries, with discussions focusing on economic cooperation, multilateral initiatives, and global challenges. Minister Konaković thanked Qatar for its support of the UN resolution on Srebrenica and invited the Qatari leadership to the 30th anniversary commemoration of the genocide. Opportunities for Qatari investment in energy, halal food production, tourism, and infrastructure were also emphasized.

First Bilateral political consultations between MFA of Bosnia and Herzegovina and MFA of Bangladesh

The delegation of MFA of Bosnia and Herzegovina was led by Secretary Mr. Edin Dilberović, while Secretary Mr. Md. Jashim Uddin headed the delegation of MFA of the People's Republic of Bangladesh.

As year 2025 marks the 30th anniversary of diplomatic relations between Bosnia and Herzegovina and Bangladesh, discussions included proposals for commemorating this milestone.

Both sides agreed to expedite the finalization of bilateral agreements currently under negotiation.





Sevdalinka has been officially added to the UNESCO's Intangible Cultural Heritage List



Sevdalinka is far more than a song—it is a heartfelt reflection of love, sadness, nostalgia, and the collective emotions of its people. This achievement underscores the artistic and historical value of sevdalinka and highlights the cultural richness of Bosnia and Herzegovina.

The journey to UNESCO recognition began in 2016 when the Association of Musicians from Tuzla submitted the initiative to the State Commission for Cooperation of BiH with UNESCO at the Ministry of Civil Affairs. In 2021, the nomination was officially presented to UNESCO with the invaluable contributions of experts, institutions, and performers—the true bearers of this unique tradition.

This recognition reaffirms Bosnia and Herzegovina's active role in enriching global cultural heritage, strengthening its international standing, and showcasing the depth of its cultural identity. At the 19th session of the Intergovernmental Committee for the Safeguarding of the Intangible Cultural Heritage, held in Asunción from December 2 to 7, 2024, sevdalinka was officially inscribed on the UNESCO Representative List of the Intangible Cultural Heritage of Humanity. This monumental recognition marks the culmination of Bosnia and Herzegovina's dedicated efforts to preserve and promote its rich cultural legacy on the global stage.

Sevdalinka, the soul-stirring traditional music of Bosnia and Herzegovina, has been brought to life by some of the most talented interpreters, each adding their unique touch to this rich musical heritage.

Iconic interpreters such as <u>Safet Isović</u>, <u>Nada</u> <u>Mamula</u>, <u>Silvana Armenulić</u>, <u>Beba Selimović</u>, <u>Hanka Paldum</u>, and <u>Zaim Imamović</u> have also left an incredible mark, preserving its authenticity while resonating with generations of listeners.

Artists like <u>Amira Medunjanin</u> and <u>Divanhana</u> have redefined sevdalinka with their emotive voice and contemporary arrangements.

The European Commission grants Protected Geographical Indications (PGI) Status to Bosnia and Herzegovina's Iconic "Livno Cheese" (Livanjski sir)



Livno cheese is the first Western Balkan food to achieve EU protection!

Livno cheese, a hard, full-fat cheese made from cow's milk, sheep's milk, or a blend of both, is renowned for its slightly sweet, nutty flavor and distinctively piquant aroma. Its exceptional character stems from livestock grazing on the fragrant pastures of the Livno region in western Bosnia, shaped by the unique interplay of Mediterranean and continental climates.

With over a century of tradition, the art of Livno cheese-making has been carefully preserved and passed down through generations, ensuring its unparalleled quality. Protected by the PGI designation, Livno cheese embodies not only its extraordinary flavor but also its deep connection to the region's climate, pastures, and time-honored production methods.



The Ministry of Foreign Affairs of Bosnia and Herzegovina intensifies its engagement in cyber diplomacy domain

Further to intensifiing its engagement in cyber diplomacy domain in regular sub-regional, regional and cross regional exchanges of lessons learned and good practicies, within the Western Balkans and the OSCE, as well as with the EU, the Ministry of Foreign Affairs contributed to the global efforts in this domain, throught participation at the 9th substantive session of the United Nations Open-ended working group on security of and in the use of information and communications technologies.



In 2020, the United Nations General Assembly, through resolution 75/240, established a new five-year Open-ended working group on security of and in the use of information and communications technologies 2021–2025. The group is mandated to further develop the rules, norms and principles of responsible behaviour of States; to consider initiatives of States aimed at ensuring security in the use of information and communications technologies; to establish, under the auspices of the United Nations, regular institutional dialogue with the broad participation of States; to continue to study, with a view to promoting common understandings, existing and potential threats in the sphere of information security, inter alia, data security, and possible cooperative measures to prevent and counter such threats, and how international law applies to the use of information and communications technologies by States, as well as confidence-building measures and capacity-building.

The representative of the Ministry of Foreign Affairs of Bosnia and Herzegovina joined The Women in International Security and Cyberspace (WiC) Fellowship and participated at the 9th Substantive Session of the Open-ended working group, actively contributing to disussions on existing and potential threats, rules, norms and principles of reponsible behaviour of States in the use of ICTs, confidence-building measures and capacity-building.

The WiC Fellowship is designed to ensure higher and effective representation of women diplomats from all regions in the United Nations cyber discussions and negotiations.

Bosnia and Herzegovina completed Draft of National Action Plan harmonized with the EU Guidelines

Bosnia and Herzegovina has succeded to complete process of the "Needs Assessment and Development of National Action Plans", run by EU CBRN CoE Initiative in cooperation with the Joint Research Centre (JRC) of the European Commission and the EU Partner Agency AESA through On-Site Assistance (OSA) Program. That process produced draft of National Action Plan (NAP) for implementation of the Strategy of Bosnia and Herzegovina for prevention of proliferation of Weapons of Mass Destruction (WMD), harmonized with EU guidelines for developing NAP's and with the EU CBRN Action Plan.

In cooperation with the EU, the process was initialled and coordinated by the Ministry of Foreign Affairs of Bosnia and Herzegovina while bearer of this process on behalf of Bosnia and Herzegovina was Supervisory Body of the Council of Mnisters of Bosnia and Herzegovina.

Once adopted, the NAP shall open doors to Bosnia and Herzegovina to acceed to available EU funds and to international donors and significantly strengthen national capacities for countering proliferation of WMD and mitigating risks of CBRN incidents.



Bosnia and Herzegovina Advances Reforms with European Union and Council of Europe Support

Bosnia and Herzegovina has made significant progress in its reform efforts, essential for its EU accession process, thanks to the joint EU and Council of Europe initiative, the "Horizontal Facility for the Western Balkans and Türkiye." At the Second meeting of the Steering Committee, held in Sarajevo, on December 12th, government officials and international partners reviewed these accomplishments and discussed future priorities.



The meeting was moderated by Head of the Council of Europe Office in Sarajevo, Bojana Urumova, and opening and clozink key remarks were delivered by Assistant Minister for Multilateral Relations at MFA BiH Ms. Aida Hodžić, Head of the Department for Mobilization of Programs and Resources of the Directorate for Coordination of Programs of the Council of Europe Mr. Schnutz Rudolf Duerr, and Head of Operations in the Department for Justice and Internal Affairs and Public Reform Administration in the Delegation of the European Union to Bosnia and Herzegovina Mr. Karel Lizerot.

They emphasized the importance of continued cooperation to ensure alignment with European standards in areas such as human rights, the rule of law, and democracy. The Horizontal Facility remains a vital tool in supporting Bosnia and Herzegovina's ongoing reform process and its path toward European integration.

Bosnia and Herzegovina, which has observer status in the alliance, was represented at the plenary meeting by Dr. Draženka Malićbegović, ambassador at large in the Ministry of Foreign Affairs of Bosnia and Herzegovina, Mr. Osman Topčagić, Ambassador to the United Kingdom of Great Britain and Northern Ireland and Ms. Danijela Babić, Minister-Counsellor.

Establishment of Honorary Consulates of Bosnia and Herzegovina in the United Kingdom of Great Britain and Northern Ireland

His Majesty's Government has given its consent to the establishment of Honorary Consulates of Bosnia and Herzegovina in the United Kingdom in 2024.

The candidacy and proposal of the Presidency of Bosnia and Herzegovina were accepted, and Mrs. Almira Delibegović-Broome has been recognised as Honorary Consul of Bosnia and Herzegovina in Edinburgh with responsibility for the consular district of Scotland, and Dr. Anes Cerić has been recognised as Honorary Consul of Bosnia and Herzegovina in Birmingham, with responsibility for the consular district of Midlands.

These appointments are another step towards strengthening relations between our country and the diaspora, as well as the affirmation of Bosnia and Herzegovina in the UK and internationally.

The Ministry of Investment of the Kingdom of Saudi Arabia presented key sectors for investment in Saudi Arabia, initiatives from the "Vision 2030" program, and opportunities for potential investors from Bosnia and Herzegovina. Specific sectors of interest for Saudi investors in Europe, including Bosnia and Herzegovina, were highlighted.

The Foreign Investment Promotion Agency of Bosnia and Herzegovina (FIPA) showcased the country's key development potentials, such as the defense industry, telecommunications, infrastructure, tourism, renewable energy, agriculture, food production, the IT sector, and others. The Ministry of Foreign Trade and Economic Relations of Bosnia and Herzegovina initiated discussions on the topic of a bilateral investment protection agreement, focusing on the legal aspects of negotiations and agreements between the two parties. Bosnia and Herzegovina's export and trade potentials were presented by the Export Promotion Agency, while the Foreign Investors Council of Bosnia and Herzegovina highlighted positive examples and experiences of foreign investments in the country to date.

The Ministry of Foreign Affairs of Bosnia and Herzegovina plans to organize a series of similar initiatives in the field of economic diplomacy in the coming period, in cooperation with interested states, with the aim of accelerating economic growth and development in Bosnia and Herzegovina and ensuring sustainable development by maximizing the country's investment potential.

The presentation of BiH food and winery products in Norway

The Embassy of Bosnia and Herzegovina in the Kingdom of Norway, in collaboration with the Foreign Trade Chamber of Bosnia and Herzegovina, recently hosted an event showcasing Bosnia and Herzegovina's food and wine products. Held in Oslo, the event brought together 10 producers of wine, cheese, and honey, who presented their products to Norwegian hotel owners, restaurateurs, retail chains, tourist sommeliers, and ambassadors agencies, accredited in Norway.



The official presentation, held at the Embassy of Bosnia and Herzegovina, was well-received by business professionals, diplomats, and sommeliers, who described the showcased Bosnian wines, cheeses, and honey as "top-quality products." Mr. Darko Pehar of the Foreign Trade Chamber highlighted the "Wine Route" project and shared a short promotional video, emphasizing the potential of Bosnia and Herzegovina as a prime destination for wine tourism. Following the presentation, business representatives from Bosnia and Herzegovina engaged in productive meetings with Norwegian companies to explore potential partnerships.



Marius Odland, a sommelier and leading wine expert from the United Wine Group, praised the Bosnian wines, noting their exceptional quality and expressing confidence in recommending them to Norwegian buyers.

Additionally, representatives from Norwegian tourist agencies found their discussions with the Foreign Trade Chamber particularly beneficial, as they are planning to organize a visit for Norwegian tourists to experience the "Wine Route" firsthand next year.
