SUBJECT: REQUEST FOR OFFERS

The Mission of Bosnia and Herzegovina to NATO in Brussels, invites potential suppliers to participate in procurement of one official vehicle. The interested suppliers are encouraged to submit their bids as per specification given below.

1. TECHNICAL CHARACTERISTICS OF THE VEHICLE

CATEGORY	Passenger car (M1) Sedan (AA)
FUEL	Petrol (not excluding petrol-hybrid)
ENGINE VOLUME	Minimum 1.400 cc
ENGINE POWER	Minimum 80 kW
TRANSMISSION DRIVE	Front wheel
WHEELS	Minimum 16"
NUMBER OF DOORS	4 (+1)
NUMBER OF SEATS	5
COLOR	Preferably black

2. ADDITIONAL EQUIPMENT AND SUPPORT

2.1. In terms of exploitation, the vehicle should have:

- Air conditioning
- Radio
- Euro 6 emission standard
- Driver's seat adjustable in height
- Electrically adjustable and heated side view mirrors
- Front and rear disc breaks
- Trip computer
- Rear parking sensors

2.2 In terms of safety the vehicle must have:

- Front and side airbags
- Anti-lock braking systems (ABS)
- Seat belts for all seats
- Cruise control

2.3. In terms of maintenance the offer must contain:

- After sale maintenance – warranties (the warranty period and service net in Europe)

3. VEHICLE PRICE

Estimated value of the procurement is up to 35.790,43 EUR without VAT. The offer has to contain the vehicle price without the tax (NET amount), tax amount and the vehicle price with tax (GROSS amount). Additionally, the offer has to contain clearly indicated discount offered (if any).

4. OFFER CONTENT

The offer has to contain detailed description of technical characteristics of the vehicle and detailed specification of additional equipment and support stated in points 1 and 2.

5. EXPIRATION DATE OF THE OFFER

The offer has to be valid for minimum for two months after the application deadline given in the Item 7 below. During this period of validity, the Mission of Bosnia and Herzegovina to NATO preserves the right to ask, in written form, for an extension of the offer validity time, if required.
